

**Market regulation PaderBow 2023, trade fair for archery, knives and outdoor clothing on
November 11th-12th, 2023 in the Schützenhof Paderborn (Schützenplatz 1, 33102
Paderborn); Organized by the "Bogenzeit" (Paderborn)**

1. The PaderBow is a trade fair for the presentation and sale of archery items, knives, outdoor clothing and related items such as leather goods and scrimshaw. She attaches importance to the professionalism of the exhibitors, the quality of the goods on offer and the balance of the offer. The organizer (Bogenzeit) can therefore make a selection from the exhibitors interested in their admission (or possibly reject them),

- if the quality and professionalism of the exhibitor are obviously not given - via the organizer decides on admission on a case-by-case basis,
- if it becomes apparent that the demand for exhibition space will exceed the supply, • if certain product groups are over- or under-represented and thus the balance of supply is jeopardized.

The details of the business processes between the exhibitor and the organizer are set out in the General Terms and Conditions.

2. The exhibitors can be both commercial and non-commercial. The exhibitors must inform the organizers truthfully about their status. Operators of new goods shops must either be in possession of a valid itinerant trade card or have registered a permanent trade with their responsible trade office (the exhibitor should be able to produce a corresponding certificate). In principle, each exhibitor is responsible for fulfilling the legal requirements for offering and/or selling any goods.

3. The exhibition area includes the exhibition hall of the Schützenhof, the Hanseatic Hall and the Ferrari Hall as well as the foyer in between, as well as the flag hall, which is only used for lectures. Construction in the exhibition hall, in the Hansesaal and in the foyer is Friday, November 10th, 2023 from 12:00 p.m. to 8:00 p.m. The exhibitors who are exhibiting in the Ferrari Hall or in the Flag Hall will set up on Saturday (November 11 2023) from 7 a.m. (possibly earlier, by arrangement with the organizer). The access routes for the fire brigade must be kept free, so the loading zone in front of the hall may only be used for loading and unloading. The access road via Fürstenweg and then Wilhelm-Kaufmann-Allee should be used for construction. You can park in the large car park on Fürstenweg/Wilhelm-Kaufmann-Allee and in the car park on Nordstraße.

4. Every participant in this event must behave in such a way that there is no danger, disruption or other annoyance to other participants or visitors. In the event of non-compliance, the organizer has the option of taking measures against these persons.

4.a) In particular, suppliers of goods that fall under the weapons law (e.g. cut and thrust weapons, knives with blade lengths over 12 cm, cf. Weapons Act §42a) are obliged to protect these goods against uncontrolled access by visitors. If the seller is interested in these goods, the seller must inform the customer that these fall under the weapons law. When sold, this item should be transported in a sealed container.

5. No sound carriers with general content may be operated.

6. The sale of pornography is prohibited.

7. Only the seat assigned by the organizer may be taken, there is no entitlement to a specific seat.

8. No goods may be offered which are criminal in content (e.g. NS symbols, etc.); See also Section 86a of the Criminal Code.

9. The instructions of the organizers and their authorized helpers must be followed.

10. The fair is open to customers and sales on Saturday, November 11th, 2023 from 10 a.m. to 6 p.m., Sunday November 12th, 2023 from 10 a.m. to 5 p.m. The entry donation is € 10.00 , reduced (pupils / students) €5.

00. Admission is free for children under the age of 12. Parents are responsible for their children.

11. A shooting range will be set up for testing bows (approx. 10 m away). The organizer commissions an authorized person with the supervision there, whose instructions must be followed.

The rules of the German Shooting Federation (DSB) apply. Safety is top priority.

12. Exhibitors must take their place at the sales stand by 9.30 a.m. on the sales days.

After the end of the trade fair, you must leave your stand as you found it (e.g. do not leave any adhesive residue on the walls, etc.). Exhibitors are only allowed to dismantle their stands after the end of the fair at 5 p.m. on Sunday.

13. Smoking is prohibited on the premises of the Schützenhof. The smokers go outside through the foyer. The emergency exits may not be used for smoking breaks.

14. In the event of violations of the market regulations, the organizers may take measures up to and including expulsion from the market, without entitlement to claims for compensation or reimbursement.

15. Place of jurisdiction for any legal disputes is Paderborn.
